<u>Board of Directors Meeting - Call to Order</u> Meeting call to order by President, Steven Goldman at 7:02pm

Steve led everyone in a moment of silence for the recent acts of violence, domestically and abroad.

Colleen Cheney conducted roll call.

Barry Fink presented the draft of 2015 Audit review.

Treasurer's Report

Vicki Minnaugh advised there is a balance of \$4,514,858.38 in the operating account, \$497,795.73 in the two CD accounts. Vicki advised the CD at Synchrony Bank was rolled over at a rate of 1.25% and the balance was reduced to \$247,000 in order to be insured. She recommends putting the residual difference towards the paving account.

Move to approve the residual CD rollover amount of \$3,795.73, to the Paving Account

There is a balance of \$1,330,993.80 in the five Money Market Accounts and a balance of \$1,109,297.03 in the cable escrow accounts.

Director's Report

Colleen Cheney: Advised that Sapphire Shores is concerned about speeding and SL's potential liability. Discussion ensued concerning the Miramar Police Road Enforcement Agreement. John Stevens provided a recap concerning traffic agreements and advised that in order to sign such an agreement, SilverLakes would need to assume insurance and indemnity costs for officers and that SL streets would need to be brought to current code. He explained that liability with a traffic agreement is not lessened with the Police Dept. He recommends not signing such an agreement with current indemnification clauses. Daron Fitch volunteered to meet with the City Police again to discuss indemnification issues. Vicki Minnaugh brought up the possibility of having speed bumps closer together.
