To the fullest extent permitted by law, the PARTICIPANT shall indemnify and hold harmless the Association, its agents and employees from and against all claims, damages, losses and expenses, including but not limited to attorneys’ fees arising out of or resulting from the performance of Easter Activities and or on SILVERLAKES property in connection with Easter Activities, including but not limited to common areas and limited common areas of SILVERLAKES. This includes but is not limited to: such claim, damage, loss or expense that (1) is attributable to bodily injury, sickness, disease and or death, or to injury to or destruction of tangible property including the loss of use resulting therefrom; and/or (2) is caused in whole or in part by any negligent act or omission of the PARTICIPANTS: including but not limited to: their family, any guest of the PARTICIPANT, any other PARTICIPANT concurrently participating in Easter Activities; (3) is caused in whole or in part by any misrepresentation made by the instructor and or their agents, employees, guests that result in injury to PARTICIPANT, their guests, family members and or other participants concurrently participating in Easter Activities; (4) the worsening of any health condition, known or unknown, of PARTICIPANT, their guest, family members, or any other PARTICIPANT of Easter Activities by virtue of their participation in Easter Activities and or by any injury suffered on SILVERLAKES premises in connection with Easter Activities. The foregoing indemnity from PARTICIPANT shall be applicable to all losses, damages, expenses or claims for damage and/or injury to any person or property, resulting from their negligence, recklessness or intentional wrongful misconduct of PARTICIPANT, and guests and or family members which utilize Easter Activities as described in this document. This indemnification shall also apply to negligent acts, conduct and omissions of the Association and its officers, directors, agents and employees related to Easter Activities.
