WHEREAS, at a duly noticed Meeting of the Board of Directors held on May 20, 2019, a majority of the Board of Directors voted in favor of adopting Rules and Regulations governing the 2019 Approved Universal Color Schemes for Silverlakes attached hereto as Exhibit "A".

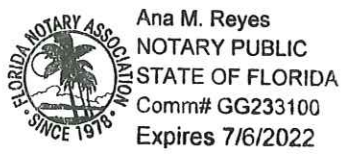
